**NOTIFICATION OF VACANCY FOR RECRUITMENT ON THE POST(S) OF PRINCIPAL IN  
THE ADARSH SANSKRIT MAHAVIDYALAYAS (ASMs) UNDER CENTRAL SCHEMES**

The Central Sanskrit University, Delhi (CSU) is the nodal agency of the Ministry of Education, Govt. of India for implementing the Central Schemes of the Govt. of India for Sanskrit Promotion. Under one of the Central Schemes i.e. “**The Scheme for Financial Assistance to Institutions Recognized as Adarsh Sanskrit Mahavidyalayas (ASMs)/ Adarsh Sanskrit Shodh Sansthan (ASSSs)**”, various institutions have been recognised as ASM/ASSS, at different parts of the country, for financial assistance. In this context, under the provisions contained in “**The Scheme for Financial Assistance to Institutions Recognized as Adarsh Sanskrit Mahavidyalayas (ASMs)/ Adarsh Sanskrit Shodh Sansthan (ASSSs) - 2022**” (Revised Adarsh Scheme-2022), the Central Sanskrit University (CSU), Delhi invites applications from Indian nationals for recruitment to the following post in various Adarsh Sanskrit Mahavidyalayas (ASMs) recognised under this Scheme, as per the details mentioned below and in the table given hereunder -

**Note :-**The above posts are single cadre posts in respective ASMs and are being advertised as per the present reservation rules.

**The applicants are advised to note following essential points:-**

Qualifications and other eligibility criteria for the above mentioned post, submission of application, procedure for applying and other terms and conditions are given here in this detailed notification for recruitment -

1. The age of retirement of Principal appointed will be as per UGC guidelines i.e. 65 years or completion of the tenure of 5 years, whichever is earlier.
2. Qualifications and other eligibility criteria & tenure for the post will be the same as per UGC/Govt. of India norms/Ordinance of CSU/Revised Adarsh Scheme-2022 and as specified below. Further, any amendments shall be strictly in accordance with the guidelines prescribed by the UGC/Govt. of India norms/Ordinance of CSU/ Revised Adarsh Scheme-2022, from time to time.

**Qualifications and other eligibility criteria for the above mentioned post are as follows :-**

**Qualifications (Essential) :-**

**A. Eligibility :**

- (i) Ph.D. degree
- (ii) Professor/Associate Professor with a total service/ experience of at least fifteen years of teaching/research in Universities, Colleges and other institutions of higher education.
- (iii) A minimum of 10 research publications in peer-reviewed or UGC-listed journals.
- (iv) A minimum of 110 Research Score as per Appendix II, Table 2 of UGC REGULATIONS ON MINIMUM QUALIFICATIONS FOR APPOINTMENT OF TEACHERS AND OTHER ACADEMIC STAFF IN UNIVERSITIES AND COLLEGES AND MEASURES FOR THE MAINTENANCE OF STANDARDS IN HIGHER EDUCATION, 2018. NOTIFICATION dated 18th July, 2018.
- (v) Ability to teach through the medium of Sanskrit.

**B. Tenure**

- (i) An Adarsh Sanskrit Mahavidyalaya Principal shall be appointed for a period of five years, extendable for another term of five years on the basis of performance assessment by a Committee appointed by the Institution/University, constituted as per UGC Regulations, 2018 and its amendments from time to time.

**Desirable Qualifications**

- (i) Knowledge of administrative procedures as per the rules of UGC and Government of India.
- (ii) Published research work of outstanding value.
- (iii) Knowledge in any Traditional Sahstra or textual criticism and manuscriptology or any relevant fields.
- (iv) Ability to teach and/or guide research students.
- (v) Working knowledge of Sanskrit, English and Hindi.
- (vi) Basic Computer knowledge.

3. The person appointed against the above advertised post(s) shall be governed as per the provisions of “The Scheme for Financial Assistance to Institutions Recognized as Adarsh Sanskrit Mahavidyalayas (ASMs)/ Adarsh Sanskrit Shodh Sansthan (ASSSs)-2022” and its amendments as issued from time to time.
4. **The incumbent/person appointed on the post will have to return to his parent organisation after completion of tenure(s).**
5. Recruitment process for above posts in Adarsh Sanskrit Mahavidyalayas shall be conducted centrally by the Central Sanskrit University, Delhi as per Revised Adarsh Scheme-2022/regulations/ordinances of UGC/CSU. Based on the recommendations of Selection Committees, the CSU shall draw the merit panels as per requirement of the above posts in the concerned ASM. The appointee(s) will be the employee of the respective Adarsh Sanskrit Mahavidyalaya (ASM) in which he/she is offered the appointment by the Management Committee of respective ASM, and not of the Government of India or Central Sanskrit University, Delhi. **The Central Sanskrit University, Delhi is acting as a Nodal Agency for conducting merely the central recruitment process under the provision of the Revised Adarsh Scheme-2022, for preparing the merit list for appointment on the vacant post in the ASMs and the candidates will not have any right to claim their appointment in the Central Sanskrit University or Government of India in any way.**
6. The applicant who wishes to apply for Principal post in numerous institutions, may choose any five institutions on his/her priority basis, in online application. However, there is also an option for choosing for the posts of all institutions (recognized under the scheme) i.e. any ASM in the country.
7. Each applicant will have to pay application fee of Rs. 3,000/- (Rs. 1,500/- for SC/ST/PwBD) which can be paid through **Online Mode only**. Any other mode of payment shall not be accepted towards application fee. Fee once paid will not be refunded. The candidate has to pay fee only once and there is no need to pay separate fee for the post of each institution.
8. After filling the online application, duly signed hard copy of the submitted application alongwith supporting documents and publications should be submitted to **“The Registrar, Central Sanskrit University, 56-57, Institutional Area, Janakpuri, New Delhi-110058”** through registered post, within 20 days from the last date of submission of online application.
  - a. *The Candidate must super-scribe on the envelope as “Application for the post of PRINCIPAL”.*
  - b. *The applicant will be solely responsible for the authenticity of the submitted information.*
  - c. *The institution shall not be responsible for any delay in filling of the application. Applications received after the last date shall not be considered. No correspondence regarding consideration of late application will be entertained.*
9. Schedule of submission of application is as under: -
  - I. **Starting date of Online Registration / Submission of application : 28.06.2025 (Saturday)**
  - II. **Last date of Online Registration /Submission of application : 28.07.2025 (Monday) by 06:00 p.m.(IST)**
10. The last date as prescribed above may be extended by the competent authority depending upon the exigency of the situation. Notification to this effect will be placed on website of the institution. So, the candidates are advised to visit the institution’s website regularly.

11. Incomplete applications, without required self-attested copies of documents shall be rejected.
12. The CSU reserves the right to alter/insert any corrections/additions in the advertisement in the event of any error etc., for which the candidates are advised to be in the lookout for announcements/notifications in the website of CSU/Concerned ASM. Information relating to selection process of above posts will be communicated through CSU's and concerned ASM's websites or email communication to the concerned candidates. Candidates are advised to regularly visit the websites of the CSU and/or concerned ASM's or their e-mail (including SPAM folder) provided in the application form. No other mode of communication will be adopted by the CSU.
13. Candidates already in service must submit their applications through proper channel. They may however send an advance copy, but if called for interview/written examination they must produce a "No Objection Certificate" from their employer. Further, these candidates should also submit a certificate from the employer or his/her authorized officer to the effect that no disciplinary proceedings are pending nor contemplated against him/her. Apart from this, the Vigilance Clearance Report shall also be furnished along with the application form or at the time of interview/documents verification.
14. The CSU reserves the right to withdraw the advertisement either partly or wholly at any time without assigning any reason to this effect. .

### **General Terms & conditions:**

1. The Central Sanskrit University, Delhi reserves the right to fill up or not to fill up the post without assigning any reason.
2. Candidates will have to present themselves for the interview/written exam/skill test at their own expenses.
3. Candidates should bring all certificates in original at the time of verification of documents/interview.
4. Applications/candidature of applicants are liable to be cancelled/rejected summarily at any stage of the recruitment process in the event of all or any of the following:
  - i. Applications being incomplete.
  - ii. Application made in the form other than the form available in the institution's website.
  - iii. Any variation in the Signatures. (All the signatures done on the Application Form and also on other Documents must be the same.)
  - iv. Fee not paid as per instructions.
  - v. Non-forwarding of Self Attested legible copies of all the relevant Certificates/Documents issued by the Competent Authority and clear self-attested photographs in support of the information given in their Application about their Educational Qualifications, Experiences, Percentage of Marks obtained, Proof of Category etc..

- vi. **Not having the requisite Educational Qualification/Experience/Category Status as on the closing date.**
  - vii. Incorrect information or misrepresentation or suppression of material facts.
  - viii. Non-receipt / Late receipt of the prescribed Application Form (Hard Copy) along with self-attested copies of the relevant documents.
  - ix. If the candidate is found using unfair means or adopting any malpractice at any stage of selection process.
  - x. Non-production of Original Certificates at the time of Verification of Documents.
  - xi. Any other irregularity.
5. Mere possession of eligibility conditions shall not entitle a candidate to be called for interview. **The date for determining the eligibility of all candidates in every respect shall be the closing date as prescribed in the advertisement for receipt of the applications.** In other words no candidate shall be called for interview if he/she does not possess the minimum qualification and experience etc. as on the closing date of the application for a particular post.
6. Applicants seeking reservation benefits available for SC/ST/ PwBD categories must submit the necessary documents justifying the claim of respective reservation as per Government of India lists/rules/norms. The cast certificate uploaded should be in the format prescribed by the Union Government and should be digitally verified.
7. Acceptance of documents/certificates/claims etc. submitted by an applicant will be subject to their verification by the competent authorities/sources. If, any claim/certificate/document is found to be false/fake/incorrect/mollified at any stage of verification before or after appointment, the document in question shall be summarily rejected and action may be initiated against the candidate for this misconduct including rejection of his/her candidature which shall lead to cancellation of his/her appointment, if already appointed.
8. **The candidates are advised to compulsorily go through the Revised Adarsh Scheme-2022 Guidelines before applying for any of the above advertised posts. 9. **The person appointed against any post shall be governed by the SCHEME FOR FINANCIAL ASSISTANCE TO INSTITUTIONS RECOGNISED AS ADARSHA SANSKRIT MAHAVIDYALAYAS/ADARSH SHODHA SANSTHANS-2022 (Revised Adarsha Guidelines -2022), the service conditions/method of recruitments as amended from time to time and resolutions of the Management Committee of the institution and rules of the Government of India/ Guidelines of the UGC, as case may be, adopted by the institution from time to time.**
10. The relaxation in deserving cases shall be provided as per the Rules/Guidelines prescribed by Government of India/UGC/institution from time to time.
11. Candidates must be in sound health. They must, if selected, be prepared to undergo such medical examination and satisfy such medical authority as the institution may require, as per rules.

12. The Candidates should keep a copy of Application printout alongwith fee submission receipt for their future reference.
13. The Central Sanskrit University, Delhi reserves the right to modify/withdraw/cancel any communication made to the candidate(s) at any stage in case of any inadvertent mistake in the process of selection as may be detected even after issue of appointment letter.
14. The Central Sanskrit University, Delhi reserves the right to alter/insert any corrections/additions in the advertisement/website in the event of any error etc., for which the candidates are advised to be in the lookout for announcements in the website.
15. The select panel of candidates of this recruitment process will be valid for one year, as per rules.
16. The Central Sanskrit University, Delhi reserves the right to withdraw the advertisement either partly or wholly at any time without assigning any reason to this effect.
17. The Central Sanskrit University, Delhi reserves the right to reject any application without assigning any reason thereof.
18. Interim enquiries shall not be entertained.
19. With regard to any ambiguity, relating to the recruitment rules in general and eligibility in respect of any post in particular, the decision of the Competent Authority of the University shall be final.
20. Statutory Warning: Selection in the institution(s) is free, fair and merit basis. Any attempt to influence the selection process detected at any stage is liable to lead to termination of candidature of service and legal action against the concerned individual will be initiated.

22. In case of any dispute in this regard, any suite or legal proceeding against the institution/University, the territorial jurisdiction shall be **Hon'ble Courts in Delhi**.
